NOTICE OF RACE (NOR)

RULES

The event is governed by the rules as defined in *The Racing Rules of Sailing*.

Section 3 'Rules of Navigation' of the Loch Lomond Byelaws 2013 apply when meeting boats that are not racing. This changes the Part 2 preamble. Competitors can view Loch Lomond Byelaws 2013 on website https://www.lochlomond-trossachs.org/wp-content/uploads/2016/07/Loch-Lomond-Byelwas-2013.pdf

RYA Prescriptions apply.

Relevant class rules apply.

SAILING INSTRUCTIONS

The sailing instructions will be available after 1000 on the first day of racing at Registration in the clubhouse. They may be available on the club website at <u>lochlomondsc.co.uk</u> under Events.

ELIGIBILITY AND ENTRY

The event is open to all boats of the Waszp, RS 200, Solo, Feva and Laser(all travellers events) and Dinghy Handicap, dependant on numbers may have an asymmetric class, fast handicap and medium/ slow handicap. Classes with entries > 5 boats will qualify for a class start. The Waszp class will qualify for their own sailing area if > 10 entries.

The Portsmouth Yardstick applies to boats racing under Dinghy Handicap classes.

Classes and starting sequence to be determined.

Eligible boats may enter by completing the entry form and sending to Cameron Dunn at euan@thedunn5.com and selecting items from the link https://loch-lomond-sailing-club.square.site and paying online to verify your entry and choices for the weekend. Entries to be in by Aug 19th 2022, entries will be accepted after this date however a late entry fee of £10 will apply.

To be an entry in the event, a boat shall complete all registration requirements and pay all fees.

We would encourage all entries to be early entries please, this will facilitate the smooth running, number of sailing areas and classes to produce an excellent event for all. Thanks in anticipation of your entries before 19th August.

SCORING

1 race is required to be completed to constitute a series.

There will be 1 discard if 4 or more races are held.

RISK STATEMENT

Risk Statement: Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in an event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate;

- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

INSURANCE

Each participating boat must be insured with valid third party insurance with a minimum cover of £3 million.

PRIZES

Prizes will be awarded to the winners and other high performing boats.
